HOW TO ENTER/RULES & CONDITIONS

Only entries on the Official Entry Form will be eligible. You may enter as many times as you wish.

1. Eligibility:

Open competition. All artists working in two-dimensional painting, drawing media, or photography are eligible. All work must be original and completed within the last two years and must not have won any previous prize or award in any other art competition.

2. Entry Deadline:

June 30, 2008.

3. Work Sample Entries:

No slides or original artwork. Only photos, digital prints, or digital files will be accepted. Artists may submit an unlimited number of entries for the competition (but a \$10 entry fee per piece still applies). Work samples will not be returned.

4. Entry Form:

Entries must be accompanied by an official entry form as appears here.

5. Sample Labeling:

Each work sample must be clearly marked with the artist's name, title, medium, and dimensions.

6. Entry Fee:

There is an entry fee of \$10 for each piece entered in the competition, payable by Visa, MasterCard, or check/money order. This must accompany the entry form. The entry fee is non-refundable.

7. Judging:

All entries received will be viewed and selected by the staff of the Greater Jackson Arts Council. Final competition will be judged by an independent juror.

8. Publication of work:

Signing the entry form will be taken as permission to publish the artwork, if chosen, in future collateral materials and media releases. Any work reproduced in this way will be given proper credit at all times. Although every care is taken by the staff to match color, there is the possibility that variations may occur in publication due to limitations of the four color printing process beyond our control.

9. Terms:

Submission of entry in this competition automatically constitutes the entrant's acceptance of all competition rules. The judges' decision will be final and no correspondence or appeal process will be granted.

10. Announcement of winners:

Acceptance letters and artwork delivery instructions will be sent out by mail in mid-July. Show opens at the Mississippi Arts Center on August 4, 2008. 1st through 3rd place winners will be notified by mail and announced at the Storytellers Ball on August 21, 2008. People's Choice Award will be chosen the night of the Ball and announced at that time.
